THIS IS A RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT -- READ BEFORE SIGNING.

On behalf of myself and my heirs, personal representatives, successors, and assigns, hereby certify that in consideration for my participation, or my child's participation, in the Blue Ribbon Run, I, the undersigned, hereby acknowledge, represent and agree as follows:

- A. 1. I acknowledge that my presence, or my child's presence, on the Town's property, and any or all of the activities occurring in, on, over, or about the Town's property, at which activities I, or my child, may be present, near, or participate in are or may be dangerous and do or may involve risks of injury, loss, or damage. I further acknowledge that such risks may include, but not be limited to, bodily injury, personal injury, sickness, disease, death, and property loss or damage.
2. By signing this RELEASE AND INDEMNIFICATION AGREEMENT, I hereby expressly assume all such risks of injury, loss or damage to me, to my child, or to any third party arising out of or in any way related to my child's presence, on the Town's property or my participation, or my child's participation, in the above described activities, whether or not caused by the act, omission, negligence, or other fault of the Town, its officers, its employees, and the run officials and emergency service personnel, or by any other cause.
3. By signing this RELEASE AND INDEMNIFICATION AGREEMENT, I further hereby exempt, release, and discharge the Town, its officers, and its employees, and the run officials and emergency services personnel from any and all claims, demands, and actions for such injury, loss, or damage, arising out of or in any way related to my presence, or my child's presence, on the Town's property or my participation, or my child's participation, in the above-described activities, whether or not caused by the act, omission, negligence, or other fault of the Town, its officers, its employees, the run officials or emergency services personnel, or by any other cause.
- B. I further agree to defend, indemnify and hold harmless the Town, its officers, employees, insurers, self-insurance pool, and the run officials and emergency services personnel from and against all liability, claims, and demands, including any third party claim asserted against the Town, its officers, employees, insurers, self-insurance pool, or the run officials or emergency services personnel, on account of injury, loss, or damage, including without limitation claims arising from bodily injury, personal injury, sickness, disease, death, property loss or damage, or any other loss of any kind whatsoever, which arise out of or are in any way related to my presence, or my child's presence, on the Town's property or my participation, or my child's participation, in the above-described activities, whether or not caused by the act, omission, negligence, or other fault of the Town, its officers, its employees, the run officials or emergency services personnel, or by any other cause.
- C. By signing this RELEASE AND INDEMNIFICATION AGREEMENT, I hereby acknowledge and agree that said AGREEMENT extends to all acts, omissions, negligence, or other fault of the Town, its officers, its employees, and/or the run officials or emergency services personnel, and that said AGREEMENT is intended to be as broad and inclusive as is permitted by the laws of the State of Colorado. If any portion of the AGREEMENT is held to be invalid, it is further agreed that the balance shall, notwithstanding, continue in full legal force and effect.
- D. By signing this RELEASE AND INDEMNIFICATION AGREEMENT, I hereby certify that I understand and acknowledge that the Town, its officers and its employees are relying on, and do not waive or intend to waive, by any provision of this AGREEMENT, the monetary limitations or any other rights, immunities, and protections provided by the Colorado Governmental Immunity Act, as from time to time amended, or otherwise available to the Town, its officers, or its employees.
- E. This RELEASE AND INDEMNIFICATION AGREEMENT shall be effective as of the date set forth below and shall be binding upon myself and my successors, personal representatives, heirs, executors, assigns, and transferees.
- F. By signing this RELEASE AND INDEMNIFICATION AGREEMENT, I hereby certify that I have read and understand the terms and conditions of said

AGREEMENT.
